## ICB NO.: ICB/012/MPMR-2013 DESIGN AND CONSTRUCTION OF SUAI SUPPLY BASE

- The Minister of Petroleum and Mineral Resources on behalf of the State of the Democratic Republic
  of Timor-Leste (hereinafter referred to as the "Employer") intends to prequalify firms for the following
  contract under this project: Design and Construction of the Suai Supply Base, Democratic Republic of
  Timor-Leste.
- 2. The Project comprises the design and construction of the Phase 1 development of the proposed multi-user integrated supply base facility located at Suai to support offshore oil and gas facilities. The works include the development of about 40 hectares of onshore land, marine facilities, breakwaterand associated mechanical and electrical works.

The facility shall be designed for minimum through-life and capital costs corresponding to international codes and standards related to the oil and gas industry.

The main marine facilities include several reinforced concrete jetty structures within a safe harbor protected by an approximately 1800m length shore connected rubble-mound breakwater located up to the -18m ACD sea bed.

The onshore development include standalone integrated mini-shore bases, office buildings, covered warehouses, staging areas for offshore fabrication, open storage yards, pipe racks, fuel tank yards, trucking load outs and parking areas, salt water Reverse Osmosis system and associated infrastructure like platform fill, main access and internal roads, drainage system, waste water treatment and sewerage system, entrance facilities, and security and fencing.

The mechanical and electrical works include MV and LV power distribution system, fire-fighting system, HVAC system, PLC/ local control system, PABX and communications system, and CCTV surveillance system.

- 3. It is expected that the Invitation for Bids will be made around August 2013.
