I. ESSENTIAL

- First degree or Postgraduate (preferred) in one of the following areas: Civil Engineering or with strong skills and experience in one or more of these areas of expertise;
- A minimum of 3 years experience as specialist or professional in the area;
- Knowledge of national and international standards for planning, design, construction standards;
- Good knowledge of a recognized system of international standards, e.g. FIDIC; Knowledge of PPP is an advantage;
- Strong, oral and written communication skills in English.
- Excellent computer skills;
- Experience working in a multicultural environment and with people of different backgrounds;
- Demonstrate understanding of public policy and regulatory frameworks and their impact on the infrastructure development.

Knowledge of Portuguese is an advantage;

II. BACKGROUND

The Government of Timor-Leste has recently entered into a 30-year public-private partnership agreement for the construction and operation of a new international container and cargo port at Tibar Bay, 10 kilometres outside the capital Dili. The project will bring the largest-ever private

investment to Timor-Leste and will see the construction of a state-of-the-art international sea port that will make a decisive contribution to meeting the country's connectivity needs for decades to come.

In terms of internal arrangements for managing the contract and overseeing the implementation the project, the Government has decided to create a dedicated Project Management Unit (PMU), which will be functionally and administratively housed within the Ministry of Public Works, Transport and Communications but will be under the strategic command of a Steering Committee comprised of the Minister of Planning and Strategic Investment, the Minister of Public Works, Transport and Communications and the Minister of Finance. The PMU will be staffed with relevant national and international professionals, who will ensure the effective management of the Concession Agreement (CA) (including its technical, health/safety/social/environmental, legal and financial aspects.
