**H. E. PRESIDENT OF THE REPUBLIC ASKS NATIONAL PARLIAMENT TO
REPAIR THE MEDIA LAW WHICH IS UNCONSTITUTIONAL**

Through Agreement decided by the Collective Judges on 11 August 2014, The Court of Appeals stated that several provisions in Decree No. 10/III about the Media Law in Article 20, about duties of journalists, violate the principle of proportionality, and also violate Articles 24 and 41 of the RDTL Constitution. The provisions included in Article 24 of Decree No. 10/III regarding foreign capital investment, violate the principle of legality and the principle of determinability and are against some principles of the Rule of Law which are included in RDTL Constitution Article 24. In addition, Article 40 of Decree No. 10/III about Contraventions violates Articles 34.3, 1, 6(b) and also 137 of the Constitution.

The Presidency of the Republic received the legal diploma from National Parliament on 26 June 2014, and on 15 July 2014 H.E. the President of the Republic, following articles 149.1 and 164 of the Constitution of the Democratic Republic of Timor-Leste, submitted this legal diploma to the Court of Appeals to conduct a preventive review of its Constitutionality. Therefore, on 19 August 2014 H.E. the President of the Republic sent a copy of the report from the Court of Appeals to the National Parliament to repair this legal diploma.
